JUDGMENT ENTRY

This matter has come for review by the Court upon its own motion after receipt of a copy of a lawsuit filed in the Court of Common Pleas, Cuyahoga County, case no. CV10722398, by the Defendant in this matter, Paul Neumann.

The Complaint for Legal Separation was filed 09/23/2009, by the Plaintiff, Pamela Neumann. An answer and counterclaim was filed by the Defendant 10/23/2009. The matter was assigned to the docket of Judge Cheryl S. Karner.

The Court finds that Judge Cheryl S. Karner has been personally named as a Defendant in the lawsuit filed in Common Pleas Court. To avoid the appearance of impropriety, Judge Cheryl S. Karner is recusing herself from this case. The Court of Common Pleas also has been named as a Defendant. All of the judges in this division of the Court of Common Pleas who would assume this case upon the recusal of Judge Cheryl S. Karner are therefore also defendants in this case.

To avoid the appearance of impropriety, all of the judges of the Court of Common Pleas, Division of Domestic Relations, are recusing themselves as well.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Judge Diane M. Palos, Judge Cheryl S. Karner, Judge Kathleen O'Malley, and Judge Leslie Celebrezze, do hereby recuse themselves from hearing this case, and apply to the Supreme Court of Ohio to appoint a Visiting Judge from another county to assume this case until its conclusion.
